Please read this notice carefully to learn how we use cookies and, based on this information, you can decide whether you allow us to store and use certain cookies for which we need your consent.

What are cookies?

A cookie is a small text file that your web browser stores on your device (computer, tablet or mobile phone) when you browse a website. Cookies are used to recognize your device when you visit certain websites. Cookies also make it easier and faster for you to use our websites, as they can remember useful information from your previous visits.

Why do we use cookies?

We use cookies for the following purposes:

- the proper functioning of the Website and of the E-shop (functional or necessary cookies)
- generating aggregated statistical data on the use of the Website and of the E-shop (analytical cookies)
- offering personalized content or advertising (marketing cookies)

What cookies do we use and under what basis?

We use different types of cookies on our website, which are described in more detail in section **Particular cookies we use** below.

1. Necessary cookies

Necessary cookies are essential and without them the transmission of messages on our websites would not be possible at all. These cookies are necessary to enable you to move around the website and use its functions. Necessary cookies include cookies that are used to remember your decision about consent to the cookies listed below.

We may place necessary cookies without your consent.

2. Analytical cookies

Analytical cookies collect anonymous statistical information about how people use our websites. In particular, they help us to better understand how users view or use our websites and highlight areas of greatest use.

We can only **place** analytical cookies on the basis of your consent, which you can give us through the settings in the relevant pop-up window (cookie banner) on our website. You can withdraw your consent at any time via the "Cookie settings" link at the footer of our website.

3. Marketing cookies

Marketing cookies record your visit on our websites in order to display personalized and targeted advertising that is of interest to users.

We can only **place** marketing cookies on the basis of your consent, which you can give us through the settings in the relevant pop-up window (cookie banner) on our website. You can withdraw your consent at any time via the "Cookie settings" link at the footer of our website.

We process personal data obtained from marketing cookies for the purposes of personalization and targeting of advertising, based on your consent. Personal data collected from marketing cookies is also processed by the third parties listed below for the purposes of personalization and targeting of advertising, based on your voluntary consent. We would like to advise you that you can give your consent for this purpose of personalization and targeting by us and the third parties listed below by consenting to the placement of marketing cookies (i.e. this will be a single legal act whereby you will in effect be giving multiple consents). If you do not wish to have your personal data processed in this way, please do not consent to marketing cookies.

How long do we keep cookies?

The periods for which cookies are stored on your device are divided into the two categories listed below. The retention period of each cookie is further listed in the section **Particular cookies we use** below.

1. Temporary (session) cookies

These cookies are only valid for the duration of the session. This means that they are only stored until you close your browser.

2. Persistent cookies

These cookies are stored on your hard drive until you delete them or they expire (in periods listed in the table below for each cookie).

Cookies that record your consent are valid for 60 months / five years. After this period, the cookie banner will reappear for you to set your cookie consents.

How can you manage cookies on your device?

You can adjust the cookie settings on our website at any time via the "Cookie settings" link at the footer of our website. You can also delete stored cookies via your web browser.

In addition, standard web browsers allow you to disable or modify the storage of cookies directly via the browser settings (*Do Not Track*).

If you disable all cookies, the website may repeatedly display a cookie banner asking you to accept or reject cookies
